Important Definitions

- I-20 Forms: Also known as "Certificate of Eligibility"; document issued by a U.S. educational institution that certifies an international student's eligibility to apply for an F-1 student visa.
 - While some universities do not provide the I-20 forms for international students, universities may still accept students who have already obtained an I-20 form. Additionally, while some universities may distribute the I-20 forms, it is possible the program may not accept international students as this depends on programspecific policies. Please contact the program director of the program you are interested in to learn more about the application process.
- International Credential Evaluation/Foreign Degree Evaluation Report: A generated report by a Commission on Dietetic Registration (CDR) approved agency used to validate U.S. educational equivalency of higher education degree(s). For a full list of CDR approved agencies, please click <u>here</u>.
- International Students: Refers to anyone who lives outside of the U.S. and its territories, interested in pursuing higher education in the U.S. with a valid student visa. <u>Note:</u> this does not refer to individuals who are U.S. citizens or permanent residents.
- **Prior Assessed Learning (PAL) Policy:** A program- specific policy regarding an evaluation that grants credit or hours of experience for content or skills that the student/intern has previously mastered.
